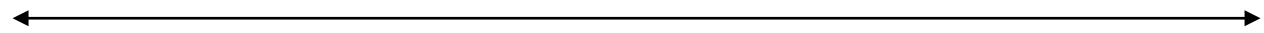
**Diane P. Brosen**

Diane earned an M.S. degree in Public Policy and a B.A. in Political Science from the State University of New York at Stony Brook.



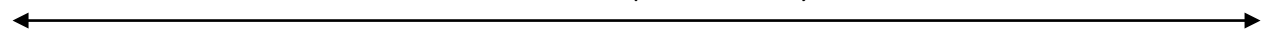

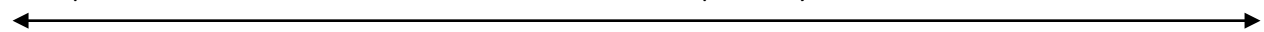
Jamie holds an AB in History from Bowdoin College, an MA from Duke in History, a JD from Fordham University Law School, and an MBA from New York University.

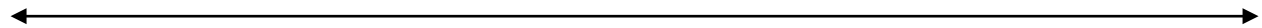
Prior to joining Wells Fargo, Nancy served as the Director of the Office of Public Finance for the State of

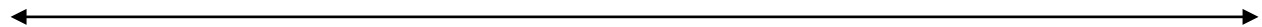

Helen holds an MBA from Pace University's Lubin School of Business and a BA in Economics from Lafayette College



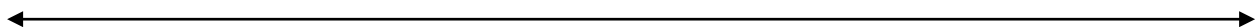
**Maria Matesanz**

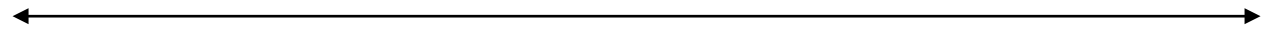

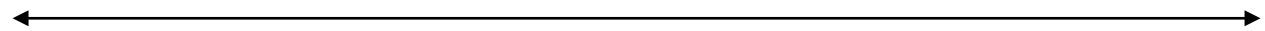

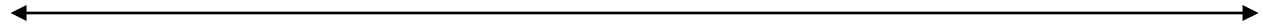
